Rules and Regulations for Temporary Off-Leash Dog Area

- For purposes of these rules and regulations adopted, all references to “off-leash area” shall mean the baseball fields adjacent to Fountain Park.
- All dogs accessing the off-leash area must have a dog park license issued by the Borough of Aspinwall, an Allegheny County issued dog license and records of receiving vaccinations for rabies, parvo/distemper and Bordetella.
- No animals other than dogs are permitted in the off-leash area.
- All dogs in the off-leash area must wear collars that display their Allegheny County license and vaccination tags. Handlers/Owners must have Borough of Aspinwall off-leash dog area permit on their person while using off-leash area. No choke, prong or spike collars are permitted.
- No more than three (3) dogs per owner or handler are permitted in the off-leash area at one time. Handler must be a responsible adult age 18 years or older.
- Dog waste must be collected by the handler and placed in the proper receptacle.
- No rawhide, treats or food for pets or humans allowed in the off-leash area.

- No dog grooming activities are permitted in the off-leash area.
- Owners and handlers of dogs must immediately report all dog bites to the Aspinwall Police Department.
- Owners and handlers of dogs must stop any dog attempting to dig within the off-leash area. Any holes must immediately be filled by the owner or handler and the Borough office must be immediately notified.
- Owners and handlers of dogs must remain within visual sight and voice control of their dogs at all times. Owners and handlers must have leashes for any dog under their supervision with them at all times.
- Dogs that become aggressive or uncontrollable must be immediately leashed and removed from the off-leash area.
- Children under age six (6) years must remain within arm's reach of a responsible adult at all times. Children ages six (6) to twelve (12) years must remain under the strict supervision of a responsible adult at all times.
- All persons using Fountain Park, the ball fields adjacent thereto and the off-leash area, assume all risks related to the use of the off-leash area. The Borough will not be held liable for any injury or damage caused by any dog on municipal property or to any person within Fountain Park, the ball fields adjacent thereto or the off-leash area.
- Failure of any person to comply with the rules established for use of the off-leash area will result in the immediate removal of handler and his or her dogs by the Aspinwall Police Department.
- The Borough reserves the right to revoke any dog park license after a dog is removed on three (3) occasions by the Aspinwall Police Department.

I, the undersigned, have read and understand the rules and regulations of the Borough of Aspinwall's "Off-Leash Dog Area". I also understand that this contract must be signed on a yearly basis along with proof of updated pet information (i.e. vaccinations and Allegheny County license).
