

2021 VENDOR FLEA MARKET RULES

Until further notice, the following COVID-19 Guidelines shall be adhered to.

THE RULES ARE:

- 1. ALL GUESTS MUST PRACTICE SOCIAL DISTANCING. STAY 6 FEET APART.**
- 2. VENDORS MUST WEAR MASKS** Customers please remember to use hand sanitizer or wash your hands for 20 seconds after leaving the market.
- 3. FOOD SAMPLING IS PROHIBITED.**
- 4. There will be available public restrooms.** All vendors and customers should be mindful to wash their hands after using the restroom.
- 5. All Customers - DO NOT TOUCH UNPACKAGED FOOD.** Point to the product you want and have an employee package it for you.
- 6. Give your money to the vendor employee.**
- 7. Vendors are to put your packaged food on their table, then the customer is to pick it up from table.** Vendors are not allowed to touch your personal shopping bags.
- 8. Make purchases and leave market.** Children are allowed in the flea market, with the guidance of a parent/guardian.
- 9. NOTE: THESE RULES MAY CHANGE IF THE GOVERNOR'S GUIDELINES ARE MODIFIED.**

FLEA MARKET RULES

- 1. No phone reservations accepted.** For information on the AVFD Flea Market, please email aspinwallvdfleamarket@gmail.com.
- 2. Reservations may be made, in person only, at the Flea Market Fireman's food concession stand.**
- 3. Reservations will be held until 7:30 a.m.** After 7:30 the reserved space will be used on a first come first served basis.
- 4. Non reserved spaces may be rented the day of use.** Walk-on persons will be given access to open non-reserved spaces. Walk on spots may not be accessed prior to 7:00 a.m. then only after being assigned a specific spot by a fireman.
- 5. Setup may begin at 5:00 a.m.** for those with a known reserved spot.
- 6. Setup may not begin for those without a reservation until the firefighter member in charge of placement arrives.**
- 7. Flea market sales hours are 7:00 a.m. to 2:00 p.m.** All flea marketers shall be out of the parking lot by 3:00 p.m.
- 8. No cars are permitted to remain in the lot during sales hours.** Renters may access the lot by vehicle to off-load their goods; then they must immediately remove the vehicle to a legal street parking space. No cars are permitted in the lot after 8:30 a.m.
- 9. Vendor parking is on the South side of Freeport Road adjacent to the railroad track.** Additional vendor parking is in the Borough Municipal parking lot on the South side (river side) at Brilliant Avenue. Access is by way of the RR crossing then an immediate left on to the lot. Vendors are to refrain from using public parking along Commercial Avenue and in the first block of Eastern Avenue. Leave those spaces for your customers. Public parking is strictly enforced by the police

department. Your cooperation in this matter is essential. Parking along Commercial and Eastern Avenues is to remain open for flea market and local business customers.

10. Farmers are permitted to park in the Fireman prescribed locations.

11. Spot rental fee is \$15.00 for each metered parking space. Space is defined as a single metered parking stall. Renter shall maintain their goods within the white line boundaries of the metered space. They shall not extend tables or goods beyond the white lines open end.

12. **Rental fee is due at 9:00 a.m., the day of use.** A fireman will collect monies due.

13. **Sales of water, beverages or food for on-site consumption, are only allowed when specifically, pre-authorized by the AVFD.** Other food and/or beverage sales incur an additional \$10.00 fee per booth. **Otherwise, water, beverage and food products are offered for sale only by the Fire Department.**

14. **All articles brought to the flea market by a vendor shall be removed by the vendor and legally disposed off-site.** No containers or trash may be deposited in the public waste containers strategically placed about the lot. No containers or waste shall be left in the parking lot. Violations may incur a littering citation.

15. **Parking is not permitted in the private Jiffy Lube lot adjacent the borough parking lot.** Parked vehicles will be tagged and possibly towed.

16. The following items may not be sold at the Flea Market.

* Pornographic materials

* Alcoholic beverages

* Drugs (of any kind)

* Prohibited offensive weapons (No gun sales)

The vendor whose printed name and signature are below admits to having received, has read, understands the PA COVID-19 RULES and 2020 Flea Market rules; and, agrees to abide by them. Rules infractions may result in expulsion from the AVFD flea market. Rules infractions and penalties are determined solely by the AVFD.
